# American Gold Star Mothers, Inc. 2023 - 2024 National Executive Board Meeting Minutes - 6/19/2023 Louisville, KY

NOTE: Immediately following the close of the National Convention Business Meeting, held June 17, 2023, President-elect Pam Stemple met with the newly elected 2023 - 2024 National Executive Board for ratification of appointed officers.

A motion to ratify the appointment of Lee-Ann Forsythe as National IT Chair was made by Second Vice President Annette Kirk and seconded by Treasurer Rose Duval. The motion carried.

A motion to ratify the appointment of Joyce Paulsen as National Service Officer was made by Second Vice President Annette Kirk and seconded by Treasurer Rose Duval. The motion carried.

A motion to ratify the appointment of Jennifer Avery as VAVS National Rep was made by Second Vice President Annette Kirk and seconded by Treasurer Rose Duval. The motion carried.

A motion to ratify the appointment of Patti Elliott as parliamentarian was made by Second Vice President Annette Kirk and seconded by Treasurer Rose Duval. The motion carried.

The business meeting was called to order at 7:57 a.m. by President Pam Stemple. (See Attachment 1.) A motion to dispense with the ritual was made by IT Chair Lee Ann Forsythe and seconded by VAVS National Rep Jennifer Avery. The motion carried.

Chaplain Cathy Bordeaux gave prayer and members recited the Pledge of Allegiance led by Second Vice President Annette Kirk. The Preamble was read by First Vice President Patti Elliott.

Secretary Chanta Vasquez conducted the roll call of officers. Pam Stemple shared that NEB Meetings by Zoom will be happening quite often to do the business of AGSM. All meetings are conducted using Robert's Rules and it is good practice for every member to have a copy and be familiar with it. Regarding online voting First Vice President Patti Elliott shared that members should always "REPLY ALL". Always read the entire thread before answering. Patti also suggested checking your organization email at least once a day.

Gold Star Mothers Weekend plans have been progressing and further details will be forthcoming. NEB should plan to arrive the Wednesday before the weekend and stay at headquarters. Pam Stemple asked that you book your flight a month in advance.

- 3. President Pam Stemple received a letter regarding placing a Gold Star Mothers National Monument "Lady" Statue at Headquarters. A motion was made by First Vice President Patti Elliott and seconded by Cathy Bordeaux to place the statue at Headquarters in DC. The motion failed. Pam Stemple will send a letter to the Monument Committee.

A request was made to the NEB by George Lutz of the Honor and Remember Organization to send a letter of support to have the Honor and Remember flag as a National Flag to be flown at all Government buildings on certain days. A motion was made to recommend that AGSM support the Honor and Remember Flag by IT

Lee-Ann Forsythe and seconded by Annette Kirk. After discussion, Patti calls the question. The motion failed.
